

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to 11101 N Stemmons Fwy and TEXO ABC AGC INC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to TEXO ABC AGC INC include 11101 N Stemmons Fwy and TEXO. The TEXO website is a ecommerce site. ## Collection of your Personal Information
